ART. 1 – GENERAL PRINCIPLES

The following notice is in compliance with the provisions of the current legislation on the right to study. Students wishing to apply for a scholarship must simultaneously possess the requirements of income, educational qualification and merit stated in this notice (as per Article 3 of the notice).

ART. 2 - COMPETITION FOR SCHOLARSHIPS

For the academic year 2019/2020 AANT - Accademia delle Arti e Nuove Tecnologie - Roma, holds a competition based on merit, educational qualification, income, to award 8 (eight) scholarships, to partially cover tuition fees, as follow:

- n. 4 (four) scholarships for students enrolled, during the 2019/2020 academic year, in the 2nd year of any First Level Academic Degree program;
- n. 4 (four) scholarships for students enrolled, during the 2019/2020 academic year, in the 3rd year of any First Level Academic Degree program

Each scholarship is worth € 1,000.00 (one thousand/00).

Each scholarship is valid only for the ongoing academic year, 2019/2020. Scholarship winners who are enrolled in a three-year course of study may participate again in the competition for the award of the scholarship the following year, provided that the necessary requisites are still present (both economic and merit as stated in article 3 of this notice).

ART. 3-APPLICATION REQUIREMENTS

The requirements for scholarship applicants are:

- a) to be regularly enrolled during the academic year 2019/2020 to the 2° or 3° year in one of the First Level courses at AANT Accademia delle Arti e Nuove Tecnologie;
- b) for students attending the 2nd year for the academic year 2019/2020: to have by the end of the summer session (July 2019) a minimum of 40 (forty) CFA. To this end, only academic credits from exams are taken into account, while those acquired via other activities are excluded from this evaluation; credits acquired by the students in years different from those above-mentioned are also excluded.
- c) for students attending the 3rd year for the academic year 2019/2020: to have by the end of the summer session (July 2019) a minimum of 80 (eighty) CFA. To this end, only academic credits from exams are taken into account, while those acquired via other activities are excluded from this evaluation; credits acquired by the students in years different from those above-mentioned are also excluded.
- d) to fall within the following income brackets during the academic year 2019/2020:
 - indicator of equivalent economic situation (ISEE) less than or equal to € 23,000.00
 - indicator of equivalent patrimonial situation (ISPE) less than or equal to € 50,000.00
- e) To not benefit from another scholarship for the same academic year. This will have to be attested with a self-declaration. The candidates must already possess the requisites stated above when delivering/sending their participation application for this competition. Documents produced after handing/sending the application or after the notice deadline will not be accepted.

ART. 4 - APPLICATION AND DEADLINES FOR SUBMISSION

There is a specific form for the application to participate in the competition, which is available at the Secretary's office or in the media section of the student's private area. The application will have to be handed it to the Secretary's office or sent via email at didattica@accademiadellearti.it by October 31, 2019 at 12 PM (noon). The application must come with the following attachments:

- indicator of equivalent economic situation (ISEE) for the year 2018
- self-declaration stating that the student is not benefiting from another scholarship (INPS, LAZIODISU, etc.) for the same academic year.

Should the student not have paid any of the fees, taxes or other payments regarding the academic year 2018/2019 or in case the student hadn't paid the 1 installment of the 2019/2020 tuition fee, the application is automatically voided.

ART. 5 - VERIFICATIONS AND SANCTIONS

AANT - Accademia delle Arti e Nuove Tecnologie checks the veracity of self-certifications, in compliance with current regulations. In case inaccuracy or falseness of any statement were to be discovered, the scholarship will be revoked and any money already dispensed will be recovered. Moreover, pursuant to article 23 of the law n° 390/91, an administrative sanction will be applied. This will result in the loss of the tax reduction benefit based on the ISEE application, plus any criminal applicable sanctions.

ART. 6-SELECTION COMMITTEE

Scholarships in art. 1 of this notice will be awarded based on candidates' qualifications and will be decided by a Selection Committee appointed by AANT Director. The committee is composed of three members, two of whom are professors, and one serves as President. The role of Committee Secretary will have to be entrusted to AANT administrative staff who will prepare the minutes.

ART. 7 - ASSESSMENT CRITERIA

- a) for students attending the 2° year for the academic year 2019/2020:
 - to have, by the end of the summer session (for the academic year 2019/2020 by July 2020 September 2020 by Directorial Decree of 16/04/2020), a minimum of 80 (eighty) CFA. To this end, only academic credits acquired from exams are taken into account, while those gained via other activities are excluded from this evaluation;
 - to have achieved a weighted average over 28/30 in the exams taken during the academic year 2019/2020 (by July 2020 September 2020 by Directorial Decree of 16/04/2020);
- b) for 3° year students, for the academic year 2019/2020:
 - to complete, by the end of the summer session (by July 2020 September 2020 by Directorial Decree of 16/04/2020 for the academic year 2019/2020) all the exams in the syllabus of the course, therefore accumulating all the required CFA. To this end, only academic credits acquired from exams are taken into account, while those gained via other activities are excluded from this evaluation;

- to have achieved a weighted average over 28/30 in the exams taken during the academic year 2019/2020 (by July 2020 - September 2020 by Directorial Decree of 16/04/2020);

The Committee will take into account all applications received and will check if requirements are met. The average calculations will take into account only exams taken, for the academic year 2019/2020, by July 2020 - September 2020 by Directorial Decree of 16/04/2020. The Committee will deduct from the average grade 1 point for every year the student has repeated a school year.

On top of merit, the Indicator of Equivalent Economic Situation (ISEE) will be taken into account, the lowest the indicator the highest the score assigned. In the event of parity, the older candidate will be chosen.

ART. 8-SELECTION RESULTS

Once scores will be assigned, selection lists will be published (one for each diploma program and one for each year). These lists are to be considered final if, within 3 (three) consecutive days after publication, nobody requests for revision. Any request for revision for the Selection Committee will need to be delivered to the Secretary's office. Any requests not properly delivered or delivered late. The administrative secretary's office will personally contact the candidates chosen by August 10 - October 10, 2020 by e-mail.

ART. 9 - SCHOLARSHIPS ALLOCATION

The amount corresponding to the scholarship will be transferred in two installments (by September 30 - December 30, 2020 and December 30, 2020 - March 30, 2021) not sooner than 60 days after the lists are published.

ART. 10 - PERSON IN CHARGE FOR ADMINISTRATIVE PROCEDURES AND JURISDICTION

The person in charge for administrative procedures, in compliance with articles 4, 5 and 6 of the law n° 241/90, is the protempore Academic Director. In the event of a dispute, the court is the Foro di Roma, with exclusive jurisdiction.

ART. 11 – ADVERTISING AND NEWS

All communications or relevant news related to this notice, classifications included, will be posted on the Institute's bulletin board and sent via email to all students regularly enrolled in the 2° and 3° year for the academic year 2019/2020. This has the value of a formal notification for all

candidates, therefore no other notification will be given. The only exception is the convocation of any suitable candidate taking the place of a winner who refused the scholarship.

ART. 12 – FINAL PROVISIONS

Data related to this notice administrative procedure is provided to the candidates and gathered in compliance with current legislation and with the principles concerning the treatment of personal data.
